### Conditions of Entry:

- The Organisers reserve the right to cancel the event should they deem that weather, beach or sea conditions are unsuitable. They further reserve the right to refuse entry to the event by any person without stating a reason.
- Entrants must arrive at the East End Slipway/The Tank Beach at 10.30 am on the day. The precise beach location will be notified on our website, Facebook page and via Twitter prior to the event and will be dependent upon conditions. Entrants must check-in with a Carnival Official who will be wearing a fluorescent jacket. Dippers will receive a ID Number only when they have checked-in and participation will not be permitted, under any circumstances, without an ID Number. ID markings must not be removed until after the close of the event.
- All Dippers must be able to demonstrate, to a suitably competent person, the ability to swim 50 metres unaided, in full clothing. They must also have minimum self-rescue knowledge and skills. Dippers must have a minimum of aggressive and passive white water self-rescue skills.
- The organisers of the event reserve the right to request photographic proof of age, to test the aforementioned abilities and to refuse any person permission to enter the water if they deem it unsafe for them to do so. Anyone unable to meet the above requirements is classified as a non-swimmer and will not be permitted to take part.
- Children under the age of 16 are permitted on condition that they are accompanied, at all times, by a parent or guardian who assumes full responsibility for their safety and well-being. Children must not be allowed to proceed further than ankle-deep water. The parent or guardian must register their own entry and must ensure that children in their care remain within an arm's length of them at all times.

- Each Dipper must be able to enter the sea unaided or be accompanied by a responsible carer who assumes full responsibility for their safety and well-being prior to, and during the event.
- The event organiser will advise you of the course on the day and you will only be directed into ankle-deep water.
- Alcohol must not be consumed at any time during the event, or by any Dipper in the day leading up to the race.
- Each entrant must remember that this is a fun event attended by families. There must be no throwing of objects or liquids, or use of foul or offensive language. Appropriate modest dress/swimwear must be worn. Behaviour deemed to be inappropriate may result in expulsion from the event.
- Marshals and First Aiders will be on the beach throughout the event. If you get into any difficulty, please raise your hand. The instructions of Marshals and other Officials must be followed.
- If a Dipper is asked to assist with a situation, this request must be obeyed. There will be a Dippers' Briefing prior to them entering the sea.
- An area of the beach will be cordoned off for the safety of both participants and spectators and must be observed. Any entry onto the beach or into the sea outside of the designated area will be deemed to be not part of the event.

### Declaration:

I confirm that I have read and will abide by all the conditions detailed above and have considered all additional risks associated with my entry into the event. I accept that participation in the event is entirely at my own risk and that I know of no personal medical conditions which may put me or others at additional risk as a result of me participating in the event. I also confirm that, in compliance with the General Data Protection Regulation 2018 (as detailed in the company Privacy Notice in place on the date stated at the head of this form) I agree to my details and those of my next of kin being recorded and stored for the duration of the above event or for as long as there is a legal basis for their retention.
