Conditions of Entry:

- Filling or emptying of fuel tanks within the designated display area is strictly prohibited at all times.
- All vehicles must be positioned within the boundaries of the display area so that any protrusions, doors, tail-lifts, etc. do not impinge upon public access areas.
- Vehicles must be taxed and drivers must be fully insured to drive the vehicle.

- Applicants must ensure that all drivers hold, and are not disqualified from holding, a licence to drive the class of vehicle being displayed and drive/ride that vehicle in accordance with current UK legislation.
- Road vehicles must be fully licensed and DoT tested (if applicable) in accordance with current UK legislation for that type of vehicle or formally declared as “not for road use”.
- No exhibit may be left running unattended at any time. All unattended vehicles must be securely braked and/or chocked with engines switched off and ignition deactivated.
- No vehicle may be run on trade plates.
- Vehicles are accepted into the event on the conditions that neither the relevant authorities nor the event organisers can be held responsible for exhibitors’/traders’ negligence resulting in any damage or injury to any vehicles or any persons whatsoever. Loss, theft or damage to exhibitors’ vehicles, their contents or equipment is entirely at the risk of the exhibitor.
- Traders must ensure that they have adequate public liability insurance cover and the organisers may request proof of this at any time.
- It is the responsibility of the exhibitors to ensure that all vehicles being driven have a minimum of third party insurance cover. UK Road Traffic Act laws apply on site.
- Vehicles entering or leaving the site are restricted to a maximum of 4 mph. No unauthorised movement of vehicles is permitted during Showtime (until after 16:00). Should you need to leave early, this must be agreed with the show marshals before moving. They will then escort you out of the site by walking in advance of your vehicle.
- No dangerous dogs are allowed on site. Any pets are the direct responsibility of their handlers and must be kept fully restrained at all times. Any deposits are to be cleared immediately and removed responsibly.
- Whilst every effort is made to ensure a successful show, the organisers accept no responsibility whatsoever for trading results due to any reason (e.g. adverse weather, show attendance, stall position, competition etc.) Furthermore, the organisers reserve the right to close the show at any time should circumstances necessitate such action.
- Vehicles may arrive at any time between 08:30 and 11:00 on Sunday 9 June 2019 and must remain on site and on display for the entire show. Vehicles may depart on that day after 16:00 hours or by prior agreement with, and under escort by, show marshals only.
- Exhibitors must, without exception or argument, comply with the event marshals’ instructions and conduct themselves in a manner that will neither inconvenience nor endanger any other person or exhibit at any time.
- Applicants wishing to display a vehicle with any form of weapon (simulated or real) must include a copy of the deactivation certificate (or written declaration of simulation) with this application form for consideration of approval.
- The organisers reserve the right to deny, remove, or have removed, any vehicle without prior notification or explanation.
- We have only 500 spaces so please come early to avoid disappointment to both you and our visitors. Please note that last year we were at full capacity by 10.45am.
