Conditions of Entry:

- Registration is from 10:00 am until 12 noon and you may start immediately after registration. The challenge can be completed after 12 noon but we cannot guarantee that marshals will be on the hills after this time.
- You must check-in with a Carnival Official who will be wearing a fluorescent jacket. You will receive a Group ID Number only when you have checked-in and you may then commence the challenge.
- The event organiser will advise you of the course on the day and their instructions must be followed.
- Dogs are permitted but are the sole responsibility of their owners who must ensure that their behaviour does not cause a nuisance to others and that any deposits are cleaned up and disposed of in a proper manner. Dangerous dogs are not permitted into the event.
